JACK HARAN
TO PRESENT A WATERCOLOR
LANDSCAPE DEMONSTRATION

Jack Haran will stress the composition of the piece he demonstrates in watercolor, which will probably be a landscape from a photograph. He will show a preliminary value sketch of the subject, emphasizing the large shapes making up the composition, and will then try to replicate the composition in a painting.

Jack has a diploma from the **School of the Museum of Fine Arts** and a Bachelor of Science in Fine Arts from **Northeastern**. He also studied at the **Cleveland Institute of Art** and with Tony Van Hasselt and Judi Wagner; Zygmund Jankowski; John Kilroy; and Alvaro Castagnet. During the past 15 years Jack has exhibited in a number of solo, group, and juried shows, locally, regionally, nationally, and internationally, and has won many awards. He is affiliated with the New England Watercolor Society, the North River Arts Society, Duxbury Art Association, Rhode Island Watercolor Society, the American Watercolor Society, and Cape Cod Art Association. His works are in collections at Georgetown University in Italy as well as at the Cultural Museum in Uruguay.

Jack states that for him, “Art is a constant educational process.The discovery of the interaction of colors, the beauty of a line, the satisfaction of a fine graphic composition, the feeling of deep space on a two-dimensional surface, none of which existed a few minutes ago, is thrilling.”

Monique Sakellarios has been painting professionally for 24 years, having been schooled at the Leonardo DaVinci School of Art and the American University, both in Cairo, Egypt. She is an internationally recognized and collected impressionist artist. She was awarded “Founders Award – Best of Show” by the National Oil and Acrylic Painters Society’s Best of America Competition in 2005. She has been honored as one of only approximately 130 Signature Members in the United States of both the Oil Painters of America and the NOAPS. Monique has received numerous other national and international awards, and her *Best in Show, First Place*, and other significant awards for shows and competitions in the New England area number in the hundreds. The Board of Directors of the Oil Painters of America described her as an artist of “...outstanding accomplishments ... and remarkable talent”

Pauline Dee of Peabody has painted oil and watercolor landscapes around New England, the shores of Maine, and the mountains of Vermont. She is a member and past president of the Saltbox Gallery. She has studied with professional teachers such as Roger Curtis, Paul Goodridge, T. M. Nicholas, Jack Jones, and others, and has judged many shows on the North Shore and Quincy. Pauline has taught oil painting for 20 years, and her paintings are in collections throughout the continental U.S. and Hawaii. She was selected for *Who's Who in American Women* and *Who's Who in the World*.

Our other judge is **Robert H. Farris, Jr.**, a lifelong painter since he began lessons at age 10 with Lynn artist Charles Impel. When he was in high school, he won junior art competitions and took on portrait commissions. He studied at the Massachusetts College of Art. Robert has been painting for over 40 years. He founded *Wood End Studio* in Lynn in 1991, where he has taught his technique since 1995. His work is included in many collections throughout the country and at the American Embassy in Lima, Peru. He has exhibited at innumerable locations; has won 6 Grumbacher Awards, and 6 Topsfield Fair

Awards; was an inductee in the Grumbacher Hall of Fame; and has been published in *The Artist Magazine*, *the North Light Magazine*, the Grumbacher Calendar; *Who's Who in the East*, and *Who's Who in America*.
